## Dear Friends,

Since our agency was founded 127 years ago, Hephzibah has met the changing needs of children and families with **creativity, flexibility, and innovation**. This ability to respond to evolving community needs with agility and ingenuity was more important than ever in fiscal 2023–2024 as we helped children thrive and families flourish in a post-pandemic world.

At Hephzibah Home, we provided a **safe and nurturing haven** for young survivors of the most extreme cases of abuse and neglect in Illinois. To help these children heal from their traumatic pasts so that they can rise above their challenges and live productive, happy, and fulfilling lives, we introduced several new supports and services and expanded our comprehensive continuum of therapies.

Because severely traumatized children often struggle with self-regulation and are more likely to react intensely if triggered, we trained our staff in a de-escalation therapy called **Ukeru**. Backed by decades of neuroscientific research, this evidence-based intervention emphasizes **comfort rather than control** and uses reassuring words and body language to safely calm children in crisis. We're pleased to report that Ukeru—which aligns so closely with our core values of nurturing personal growth in creative ways while affirming the dignity of every individual—is giving the children at Hephzibah Home the additional validation and support they need to process their trauma and learn to love and trust again.

While our staff was being trained in Ukeru, two enterprising Hephzibah therapists were helping the children deal with another symptom of trauma: a hypersensitivity to stimuli that can lead to sensory overload.

With limited resources and a lot of creativity, they cleared out an underutilized room at Hephzibah Home and transformed it into a **tranquil oasis** where the children can relax, unwind, and learn mindfulness practices that will help them self-regulate more effectively throughout their lives. When children grow up under conditions of constant threat, all of their internal resources are directed toward survival. With their brains and bodies in chronic stress-response mode, they have difficulty processing information, managing their emotions, and navigating transitions. To help the children at Hephzibah Home overcome these challenges, we created and filled a new **transition specialist** position during the fiscal year. This new staff member works with the Illinois Department of Children and Family Services and other referring agencies to identify the children who will benefit most from our programs and services; helps ease the children's transition into residential care; and provides parent coaching, family therapy, and other transition services to **ensure successful placements** as the children continue their healing journeys in

loving homes with relatives or foster families.

Because inclusion is another one of our core values, Hephzibah has worked for decades to **protect the rights of LGBTQ+ foster children**, provide affirming care, and place these children in welcoming and supportive foster and adoptive homes. During the fiscal year, we continued this tradition by enrolling in **All Children-All Families**, the only national program dedicated to LGBTQ+ inclusion in child welfare. We are proud to be a part of this certification program offered by the Human Rights Campaign Foundation and to give our employees the resources, technical assistance, and training they need to **ensure that every child we serve is welcomed, seen, celebrated, and supported.**

Our Family Based Services staff was also on the leading edge of change as they harnessed the power of emerging technologies to locate more **kinship caregivers** for the foster children we serve. Because children placed with relatives or trusted family friends have better outcomes and are more likely to report that they “always felt loved,” Hephzibah was the first child welfare agency in Illinois to implement a groundbreaking **family-finding and engagement software program**. This software streamlines every phase of the family-finding process—from identifying and reaching out to potential kin to creating family trees—to ensure that foster children can stay connected to their communities, their cultural traditions, and the people they know and love. We were also finding creative ways to address the growing problem of **housing insecurity** for some of Illinois’ most fragile families. According to a 2023 report released by the National Low Income Housing Coalition and Housing Action Illinois, there are 443,746 extremely low-income renter households in Illinois, but only 150,392 affordable rental properties available to house these families. Faced with yearslong waitlists at housing advocacy organizations, one of our **Intact Family Services** caseworkers teamed up with a Hephzibah intern to contact landlords directly, tell them about our mission, and compile a list of **affordable housing options** organized by criteria such as location, availability date, and property size. By building direct relationships with landlords, this dedicated team is keeping families out of shelters and off the streets, reducing housing costs to free up funds for other necessities such as food and transportation, and ensuring that children in families of all income levels have safe and stable homes where they can grow and thrive.

Here in Oak Park, our Day Care team was helping more than 800 children in grades K–5 catch up on their **social-emotional development** after the remote learning and restricted peer interactions of the pandemic. It was the right intervention at the right time, and—despite missing two key years of socialization during COVID—these children are now

# A Place to Unplug

“Almost **everything will work again if you unplug** it for a few minutes, including you.”

— Anne Lamott, *author*

REMEMBER THE “BEFORE TIMES”? Before the digital age, when kids spent summer afternoons lying in the grass and gazing up at the clouds? They called it “doing nothing,” but they were actually doing something very important: **regulating their sympathetic nervous systems** by taking a break from the sometimes overwhelming cognitive and sensory input that is an inescapable part of modern life.

Today, kids are taking in more information than ever before. Because their brains are still developing,

they’re more prone to sensory and cognitive overload than adults. This chronic overstimulation, according to neuroscientific studies, can literally shrink the brain—and it’s especially damaging for children suffering from complex trauma, like the young survivors of neglect and abuse at Hephzibah Home.

“Because trauma can affect a child’s ability to process, regulate, and respond to sensory information, our kids were frequently overstimulated,” notes Hephzibah art therapist Jenny Wise.

The children clearly needed a place to chill out—and some instruction in **mindfulness techniques** to enhance their emotional health and well-being. So, in late 2023, Wise and clinical coordinator Carlotta Abogado approached the leadership team at Hephzibah Home about repurposing an underutilized space on the first floor to create a **Mindfulness Room**.

“We already had a Gross-Motor Room in the building, which the children could use when they needed

to run around and release some energy, so it made sense to create a place where they could do the opposite: curl up in a cozy chair, read, stretch, do yoga, or put on headphones and listen to music," says Wise.

"We saw the Mindfulness Room as the 'yin' to the 'yang' of the Gross-Motor Room," adds Abogado.

Once Wise and Abogado got the green light to move ahead with their idea, they cleared out the room, painted the walls a peaceful shade of blue, and installed a sensory light to promote relaxation. Then they purchased furniture that the children could sink into for some much-needed decompression sessions, including kid-sized recliners and a rotating chair upholstered in

irresistibly soft faux-fur fabric. Finally, they filled the room with yoga mats, blankets, pillows, battery-operated candles, noise-canceling headphones, art supplies, origami paper books, fidgets, and some additional items requested by the children.

By early April, the Mindfulness Room was a reality. Notably, there wasn't a screen in sight.

"We wanted it to be a tech-free space where the children could practice relaxation and centering techniques, get in touch with their physical and emotional needs, and be present in the moment," says Wise.

Since then, the room has become a **sanctuary—and a place for healing.**

"The children we serve at Hephzibah Home come from traumatic situations and carry that trauma in their bodies," notes Abogado. "Their sympathetic nervous systems are in overdrive, and it doesn't take much to trigger a fight-or-flight response. By creating this environment

that is quiet and calm—and teaching them how to ground themselves and practice evidence-based mindfulness techniques—we are giving them some agency over their state of being and helping them develop self-regulation skills that will help them thrive throughout their lives." ♥



# Keeping Kids Connected to Kin

“My whole life, I was just 58 miles and a couple of questions **away from family.**”

SIXTO CANCEL, BORN TO A drug-addicted, impoverished mother, was placed in foster care when he was 11 months old. In a 2021 *New York Times* guest essay with the heart-wrenching title, “I Will Never Forget That I Could Have Lived With People Who Loved Me,” he wrote, “I was told I was loved, that I was a part of a family, yet I would always find myself moved to a new placement, with all my stuff in a trash bag.”

At the age of 29, long after he’d

aged out of the foster care system, Cancel discovered that an aunt living less than an hour’s drive away would have taken him in and loved him. In his essay, he concluded, “My foster care placements failed not because I didn’t belong in a family, but because the system failed to identify kinship placements for me and lacked enough culturally competent community services to keep me in a home that had a chance at success.”

Cancel’s assertion is supported

by an in-depth review of more than 100 research studies, which revealed that children and youth placed within kinship networks had more stable placements, better mental and emotional outcomes, and more intact family relationships.

Currently, only about a third of all U.S. foster children are placed in kinship care, which includes relatives such as aunts, uncles, grandparents, siblings, and non-relative extended family members referred to as “fictive kin.”



Hephzibah is harnessing the power of **innovative family-finding technologies to place more foster children in “kinship care”** with relatives or trusted family friends—so they can stay connected to their communities, their cultural traditions, and the people they know and love.

It’s not for lack of trying. In the past, family finding was a labor-intensive process that required months of research, outreach, interviews, and documentation. For decades, child welfare agencies did this manually. The process was burdensome for agencies with limited resources, and some families were so fractured that locating relatives or fictive kin was like finding a needle in a haystack.

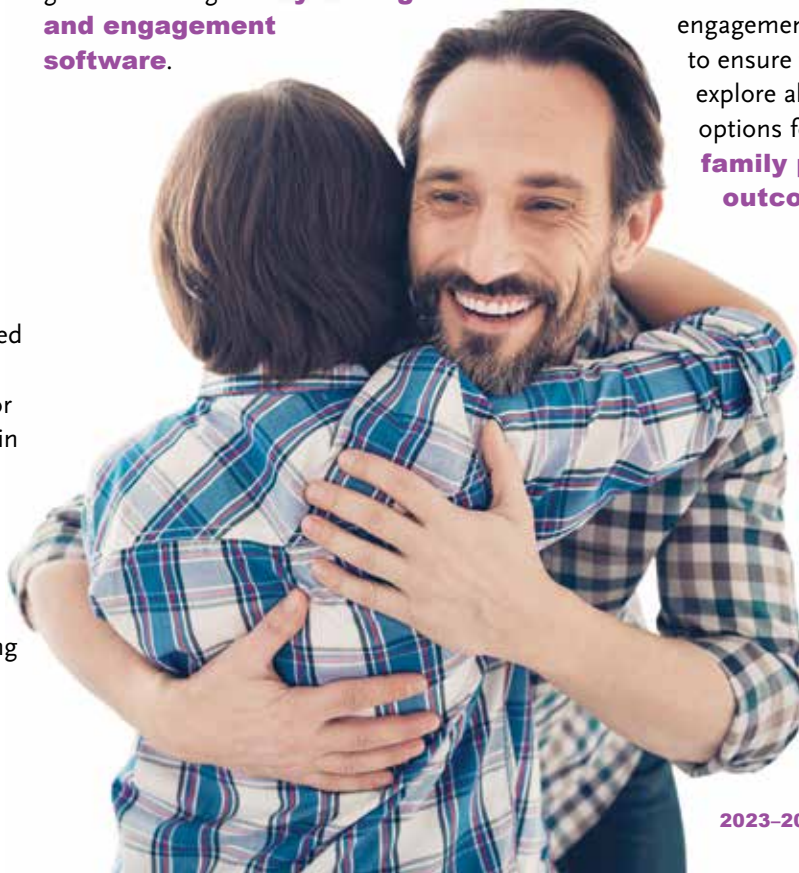
Director of Family Based Services Julie Dvorsky remembers one case in particular. “We were trying to find a kinship placement for a teenager, but we weren’t getting

anywhere. We paid an online search service and received 200 pages of phone numbers and addresses in no particular order. Two interns sifted through the results for more than a week, identified potential leads, placed over 50 calls, and finally located a relative who could take him.”

In late 2022, Hephzibah hired a dedicated family-finding specialist to expedite the process. But the real break came in 2023 when Binti—an award-winning company with a mission to transform child welfare through technology—introduced its groundbreaking **family finding and engagement software**.

Hephzibah was the first child welfare agency in Illinois to adopt this technology, thanks to a generous grant from the **John F. Smielke Foundation**. After five months of training and preparation, Dvorsky and her team conducted their first kinship searches in September 2024.

“This software is a game changer,” Dvorsky reports. “It streamlines every phase of the family-finding and engagement process, which will enable us to easily identify potential kin, map complex family relationships so we can create a family tree for each child, and track our outreach and engagement efforts to ensure that we explore all kinship options for **better family placement outcomes.**” ♥



# Ready for Life

IT'S NO SECRET THAT KIDS JUST DO BETTER when their social-emotional needs are met. In fact, hundreds of studies involving more than a million PreK–12 students worldwide have established that social-emotional learning programs have a positive impact on student well-being, academic performance, and life outcomes.

Nobody knows this better than Hephzibah Day Care Director Amy O'Rourke, whose background as a social worker informs much of her work with the children in Hephzibah's after-school and summer camp programs.

“We have always recognized that school-age children need a lot of social-emotional support as they learn how to navigate the world,” says O'Rourke. “Over the years, our program has evolved from a traditional day care model with a focus on recreation to a **youth development program** with a strong emphasis on social-emotional growth and well-being.”

In 2019, Hephzibah created a dedicated social services and training coordinator position. Currently funded by the **Community Mental Health Board of Oak Park**

**Township**, this position ensures that all Day Care staff members—from the supervisors to the youth development specialists who work directly with the children—have the skills and self-awareness they need to model respectful and appropriate behaviors, build nurturing relationships, and integrate social-emotional learning into everyday activities.

Then the pandemic hit, and life changed overnight. Remote learning became the new normal and restricted peer interactions stalled the children's social-

emotional development. By the time these restrictions were lifted, the pandemic's babies, toddlers, and preschoolers had entered the school system—and they were struggling.

"Children in the Oak Park community, like children everywhere, had missed out on two key years of socialization during the pandemic," O'Rourke points out. "Our youth development specialists helped jump-start their social-emotional growth by giving them the extra time, space, and support they needed to work on skills such as being a good friend, advocating for themselves and others, and expressing their feelings in safe and appropriate ways."

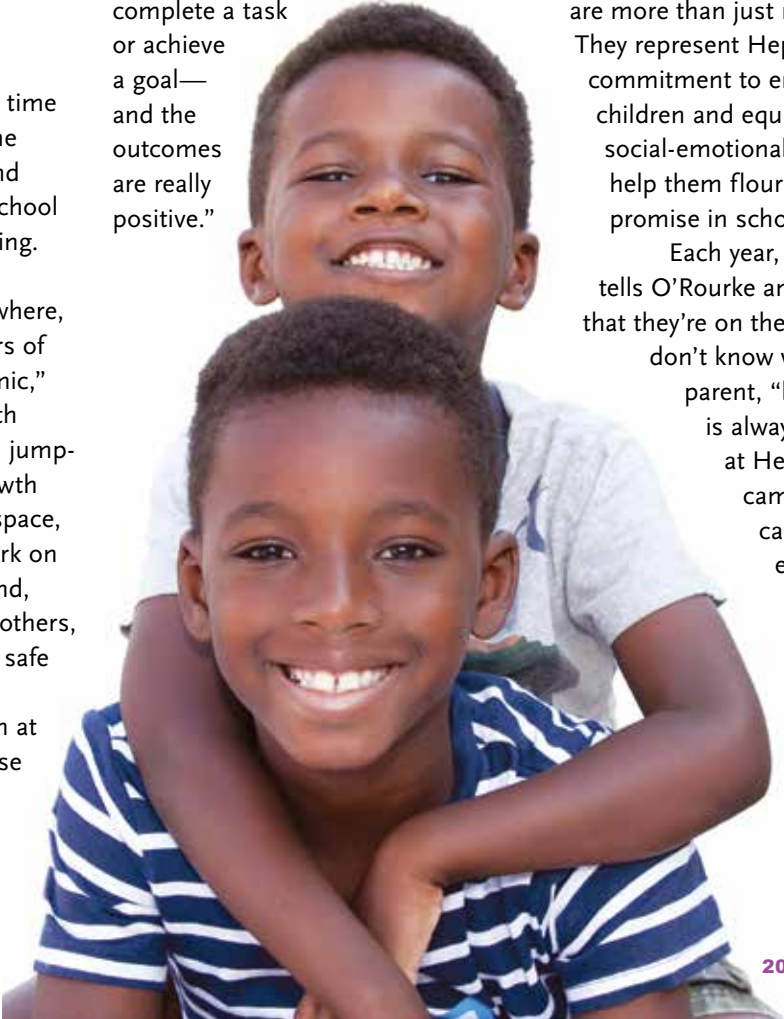
It was the right intervention at the right time—and, today, those same children are thriving.

"From the children's perspective, Hephzibah is a place to hang out with friends and have fun, but **social-emotional skill-building is integrated into everything we do,**" says O'Rourke. "If children are having a hard time, for example, we acknowledge and affirm their feelings first and then ask, 'Well, what are your options?' This approach helps foster a sense of self-efficacy—the belief that they can successfully complete a task or achieve a goal—and the outcomes are really positive."

According to O'Rourke, social-emotional learning also helps foster **a sense of belonging**. "We reinforce that feeling of belonging by making it clear that everyone is on the same team," she notes.

To help communicate this concept, O'Rourke relegated the old employee t-shirts printed with the word "STAFF" to the recycling bin and replaced them with more egalitarian garb. Kids and staff alike now sport t-shirts emblazoned with the words "**TEAM HEPHZIBAH**." The t-shirts are more than just morale boosters. They represent Hephzibah's deep commitment to empowering the children and equipping them with social-emotional skills that will help them flourish and fulfill their promise in school and in life.

Each year, parent feedback tells O'Rourke and her team that they're on the right track. "I don't know why," noted one parent, "but my daughter is always her best self at Hephzibah summer camp. We tried other camps, but in this environment and with these people, she blossoms." ♥

## Giving the Gift of Belonging

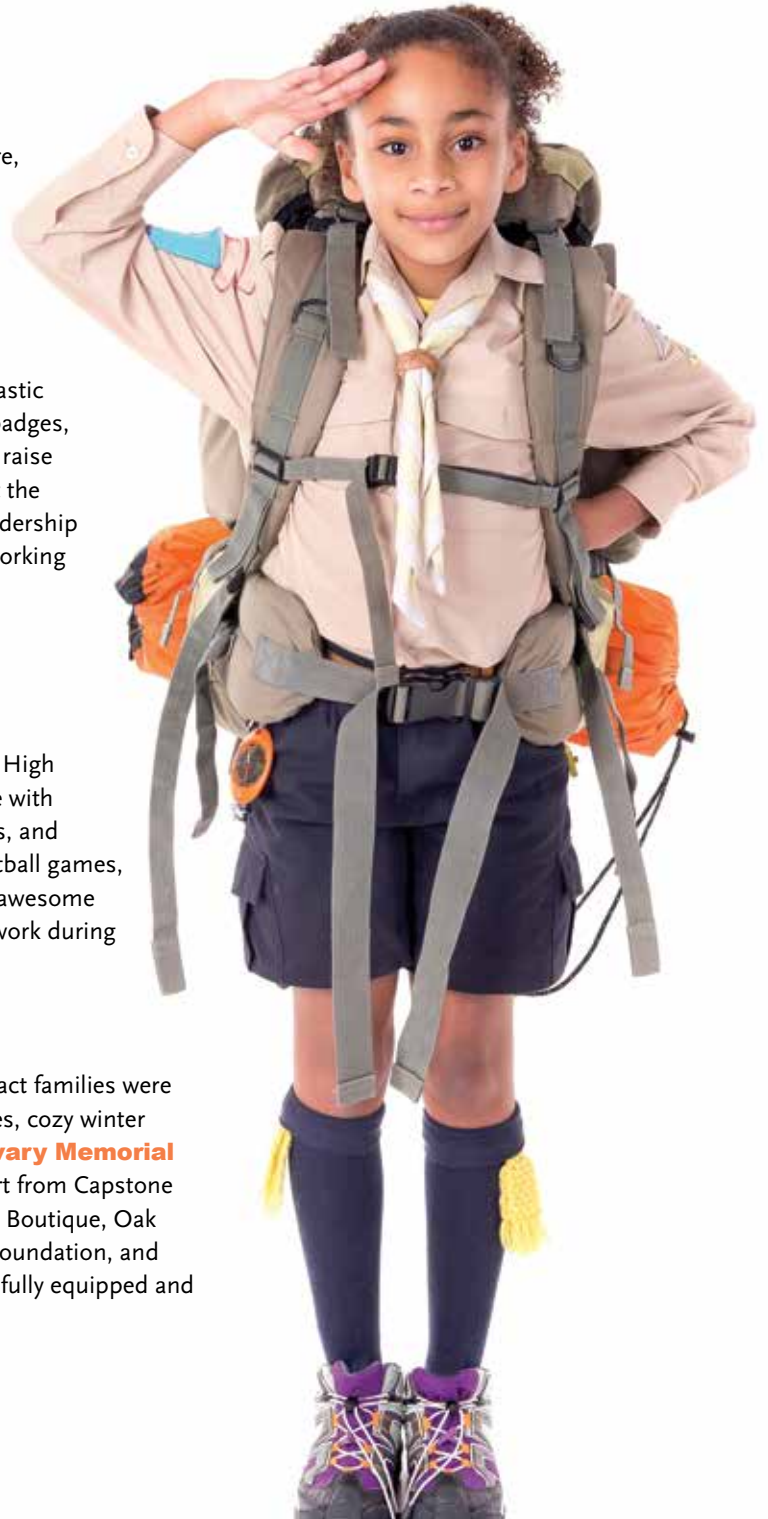
When families fracture and children are placed in substitute care, they miss out on some of the best parts of childhood, such as joining a scouting troop. So she introduced us to Irene Crea, the community relationship manager of the **Girl Scouts of Greater Chicago and Northwest Indiana**, who formed Girl Scout Troop 409 just for them. Cheered on by four enthusiastic volunteer troop leaders, our Girl Scouts are now busy earning badges, rising to new challenges, and even selling Girl Scout cookies to raise funds for new adventures. Along the way, they're learning about the importance of kindness and community service, developing leadership and life skills, and enjoying the camaraderie that comes from working together to make the world a better place.

The **Huskie Helpers**, a student club at Oak Park River Forest High School, brightened the lives of the children at Hephzibah Home with year-round activities and outings, served as positive role models, and taught the children how to laugh and have fun again during football games, trips to the ice rink, movie nights, holiday activities, and a truly awesome pirate-themed celebration to reward the children for their hard work during the academic year.

In August 2023, more than 250 children from 125 foster and intact families were outfitted in style with sturdy backpacks, scads of school supplies, cozy winter coats, and more during our **Back-to-School Event at Calvary Memorial Church**. 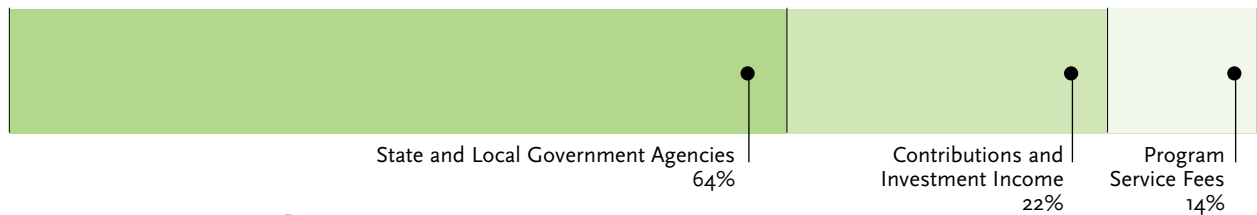

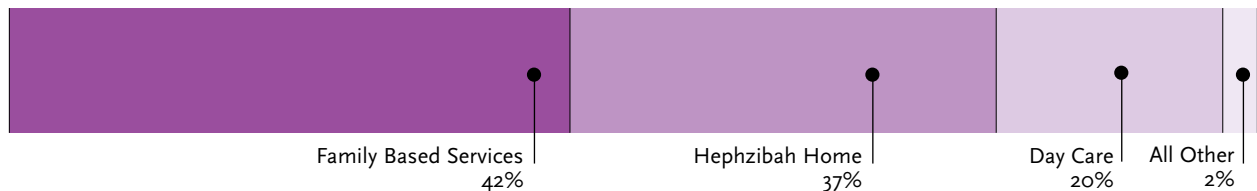
### Sources of Funding
