HEPHZIBAH HOME SERVES SOME OF THE YOUNGEST VICTIMS OF SEVERE ABUSE, NEGLECT AND TRAUMA AND CHILDREN IN NEED OF BEHAVIORAL INTERVENTION, AGES 3-11 IN ILLINOIS. AT HEPHZIBAH HOME WE OFFER CHILDREN A SAFE HAVEN, AND A PLACE FOR THEM TO STABILIZE AND HEAL SO THAT THEY MAY EVENTUALLY RETURN TO A HOME ENVIRONMENT. HEPHZIBAH HOME OFFERS EACH CHILD AN INDIVIDUAL TREATMENT PLAN BASED ON THEIR SPECIFIC NEEDS. OUR CLINICAL TEAM PROVIDES COMPREHENSIVE THERAPEUTIC SUPPORT TO HELP CHILDREN HEAL FROM TRAUMA AND DEVELOP HEALTHY BEHAVIORS AND LIFE SKILLS, AND OUR EDUCATION TEAM SUPPORTS THE ACADEMIC NEEDS OF THE CHILDREN. THE SUPPORT FOR THE CHILDREN COMES IN THE FORM OF THERAPIES SUCH AS ART AND PET THERAPY, MUSIC AND MOVEMENT THERAPY AND SENSORY MODULATION TREATMENT. OUR TEAM HELPS CHILDREN MEET THEIR GOALS AND DEVELOP THE VITAL SKILLS THEY NEED TO MOVE TO FOSTER OR PERMANENT PLACES. IN FY25, 31 CHILDREN WERE SERVED IN THE HEPHZIBAH HOME.

WE HELP CHILDREN HEAL AND PREPARE THEM FOR THE NEXT STEP IN THEIR FOSTER JOURNEY, WHETHER IT IS RETURNING TO BIOLOGICAL FAMILY MEMBERS, OR INTO AN ADOPTIVE HOME. HEPHZIBAH ALSO RECRUITS, TRAINS, AND SUPPORTS FOSTER PARENTS WHO OPEN THEIR HOMES TO CHILDREN IN NEED. IN FY25, 114 CHILDREN WERE SERVED IN THE FOSTER CARE PROGRAM.

DAY CARE - HEPHZIBAH'S AFTER SCHOOL PROGRAM SERVED MORE THAN 800 CHILDREN FROM DIVERSE SOCIOECONOMIC BACKGROUNDS FULFILLING A CRITICAL NEED IN THE OAK PARK COMMUNITY FOR AFFORDABLE, NURTURING, AND ENRICHING AFTER-SCHOOL CARE FOR ELEMENTARY SCHOOL-AGED CHILDREN. WE OFFER A DYNAMIC CHILDCARE EXPERIENCE FOR CHILDREN IN GRADES K-5 AFTER SCHOOL AND FULL-DAY CARE ON SCHOOL HOLIDAYS AT EACH OF THE EIGHT DISTRICT 97 ELEMENTARY SCHOOLS IN OAK PARK. WE ALSO OFFER FULL-DAY SUMMER DAY CAMP MONDAY-FRIDAY IN OAK PARK FOR CHILDREN OF WORKING PARENTS. THIS PROGRAM IS UNIQUE WE OFFER A SLIDING-FEE PAY SCALE, BASED ON INCOME LEVEL. SIBLING CAMPHEPHZIBAH COORDINATES AN ANNUAL SIBLING CAMP FOR YOUTH IN OUR PROGRAM, AGES SIX YEARS AND OLDER, THAT ARE SEPARATED IN CARE FROM THEIR SIBLINGS. THIS IS A THREE-NIGHT, FOUR-DAY CAMP THAT TAKES PLACED AT CAMP WHITCOMB MASON IN HARTLAND, WISCONSIN. SIBLING CAMP IS IMPORTANT IN CREATING A SENSE OF CONNECTION AND CONTINUITY BETWEEN SIBLINGS, HELPING TO BUILD POSITIVE CHILDHOOD MEMORIES, AND ENCOURAGING CONFIDENCE AND SELF-ESTEEM. MOST IMPORTANTLY, SIBLING CAMP ALLOWS THE CHILDREN TO JUST BE KIDS, UNENCUMBERED BY THEIR PAST AND HAVE A WONDERFUL TIME PARTICIPATING IN ACTIVITIES THAT ALL CHILDREN SHOULD HAVE A CHANCE TO EXPERIENCE. THROUGH SIBLING CONNECTIONS MADE AND STRENGTHENED AT THE CAMP AND AT OTHER TIMES THROUGHOUT THE YEAR, THE YOUTH MAINTAIN VALUABLE LINKS TO THEIR FAMILY, WHICH IS SO IMPORTANT IN BRINGING HOPE AND HAPPINESS TO THE CHILDREN.INTACT FAMILY SERVICESTHE INTACT FAMILY SERVICES PROGRAM IS DESIGNED TO MAKE "REASONABLE EFFORTS" TO STABILIZE, STRENGTHEN, ENHANCE, AND PRESERVE FAMILY LIFE BY PROVIDING SERVICES THAT ENABLE CHILDREN TO REMAIN SAFELY AT HOME. THIS PROGRAM ASSISTS FAMILIES TO MEET MINIMUM PARENTING STANDARDS THROUGH PROFESSIONAL ASSESSMENT OF THE FAMILIES' PROBLEMS AND THE PROVISION OF NECESSARY SERVICES. THE FAMILIES IN THIS PROGRAM ARE REFERRED FROM THE DIVISION OF CHILD PROTECTION (DCP) THROUGH THE DEPARTMENT OF CHILDREN AND FAMILY SERVICES. HEPHZIBAH'S INTACT PROGRAM PROVIDES SERVICES TO THE COOK CENTRAL REGION OF THE DEPARTMENT. OUR CONTRACT CAPACITY IS 100 FAMILIES AT ANY GIVEN TIME, AND THE CASELOAD RATIO IS 10:1. POSITIVE PARENTING PROGRAM (TRIPLE P)HEPHZIBAH PROVIDES AN EVIDENCE-BASED MODEL OF INTERVENTION CALLED POSITIVE PARENTING PROGRAM (TRIPLE P). TRIPLE P IS A PARENTING INTERVENTION WITH THE MAIN GOALS OF INCREASING THE KNOWLEDGE, SKILLS, AND CONFIDENCE OF PARENTS AND REDUCING THE PREVALENCE OF MENTAL HEALTH, EMOTIONAL, AND BEHAVIORAL PROBLEMS IN CHILDREN. THE AGE RANGE FOR CHILDREN BEING SERVED BY THIS PROGRAM IS FROM 6-12 YEARS. THE TRIPLE P CURRICULUM HAS THE PARENTS FOCUS ON ONE CHILD IN THEIR HOUSEHOLD THAT THEY STRUGGLE WITH THE MOST.
